## **Re: Notification of a Change of Operating/Legal Name**

We are writing to confirm that we have received your notification of a change of operating name from Avalon Career College to Avalon Community College and a change of legal name from Avalon College Limited to Avalon Community College Limited. We have updated our records accordingly.

### Certificate

Your new designation certificate is included here as an attachment.

Certificates must be printed and posted in a prominent place at the location for which they have been issued and on your institution's website. They must remain posted until they expire, or until they are surrendered or cancelled.

The certificate issued for Avalon Career College is no longer valid.

### Conditions attached to certificate

Section 8(1) of the *Private Training Act* (PTA) provides that the registrar may attach a condition to your certificate for the purposes of consumer protection and quality assurance.

The following condition is attached to your certificate:

1. If your institution is appointed to offer a comparable program under s. 18(2) of the PTA, you may not charge tuition to students enrolled in the comparable program other than tuition owing to the closed institution as confirmed by the registrar.

You must comply with the condition listed above. Once a condition is no longer required, it may be removed by the registrar.

## Change of control and fiscal year

The registrar must be notified at least seven days in advance of any change of control of an institution.

For a company, a change of control means a change in the major shareholder (a shareholder holding more than 50% of the voting shares). For a partnership, a change of control means a change or alteration in the membership of the firm.

Institutions considering a change in fiscal year must notify the registrar at least 90 days in advance. You are encouraged to contact PTIB to discuss implications of this change.
